R1 Permitted Uses:

Single-Detached Dwelling, RTM, Manufactured or Modular Homes

R3 Permitted Uses:

Single-Detached Dwelling, RTM, Manufactured & Modular Homes, Semi-Detached Dwellings, Townhouse, Duplex and Multiple Unit Dwellings

Multiple lot purchases with the intent to Consolidate lots are allowed.

Property Information:

- Multiple lot purchases are available with intent to consolidate lots.
- Permitted land uses as per each zone as set out in the Zoning Bylaw 02-22.
- Purchaser will be responsible for installing their water and sanitary sewer service lines from the main stub provided for each lot to their building and all other utility connections.
- Each lot must have 1 principal building and follow all regulations as per Zoning Bylaw 02-22.

Possession:

- Deposit of 10% of purchase price plus GST.
- Purchaser is responsible for fees of Title Transfer.
- Property Taxes will be adjusted as per possession date.

Build Time Requirements

- Development and Building Permits must be obtained within 12 months of date of sale agreement.
- Construction may commence once possession of the lot is granted.
- Occupancy Permit must be obtained within two (2) years after approval of Building Permit.
- 25% penalty of the purchase price shall be charged if construction does not commence within two (2) years from the date of Sale Agreement.
